- 1) Call to order
- 2) Roll call
- 3) Verification that proper notice was given
- 4) Select Chairperson and Vice-Chairperson
- 5) Verify that at least one Board of Review (BOR) member has met the annual mandatory training requirements (verified 6/4/2024)
- 6) Verify that the Town has an ordinance for confidentiality of income and expense information provided to the Assessor under state law (Wis. Stat. § 70.47(7)(af))
- 7) Verify that the Town has policy on procedure for sworn telephone or sworn written testimony request
- 8) Verify that the Town has an ordinance for policy on procedure for waiver of BOR hearing requests
- 9) Verify that the Town has an ordinance to appoint alternate members to the BOR
- 10) Review of new laws
- 11) Filing and summary of Annual Assessment Report (including the level of assessment) by Assessor
- 12) Receipt of the assessment roll by the Clerk from the Assessor
- 13) Receive the Assessment roll and sworn statements from the Clerk
- 14) Review the Assessment Roll and perform statutory duties:
 - a. Examine the roll
 - b. Correct description or calculation errors
 - c. Add omitted property
 - d. Eliminate double assessed property
- 15) Discussion/Action certify all corrections of error under state law (Wis. Stat. § 70.43)
- 16) Discussion/Action verify with the Assessor that open book changes are included in the assessment roll
- 17) Allow taxpayers to examine assessment data
- 18) Consideration of:
 - a. Waivers of the required 48-hour notice of intent to file an objection when there is good
 - b. Requests for waiver of the BOR hearing allowing the property owner an appeal directly to the circuit court
 - c. Requests to testify by telephone or submit a sworn written statement
 - d. Subpoena requests
 - e. Act on any other legally allowed or required BOR matters
- 19) Review Notices of Intent to File Objection



- 20) Proceed to hear objections, if any, and if proper notice/waivers given, unless scheduled for another date
- 21) Consider/act on scheduling additional BOR date(s)
- 22) Motion to Adjourn
