- All apparatus and equipment are functioning properly and ready to respond.
- Brush 1 will have new tires installed this week.

Training:

- Fire Chief attended a Pipeline Safety CORE exercise.
- Fire Chief and Lieutenant Paoli attended Active Shooter/Rescue Task Force training at Wausaukee High School on Saturday, May 11th.
- Justin Walk successfully completed State Certified Firefighter 1 and Hazardous Materials Operations certification testing.
- Jordan DeForge, Cienna Grawey and Max Heckel have successfully completed State Certified Firefighter 2 certification testing.
- We are conducting pressure testing of all our fire hose in place of In-House training this month. So far in two nights we have tested 118 hose lengths totaling almost 6,000 ft of hose. One more night will be needed to complete testing.

Fire Prevention, Education and Community Involvement:

- Firefighters assisted at the April 27th Bellin 5K Heart Run by providing traffic control and scene safety.
- Free smoke alarms are still available for installation at households within the Town of Peshtigo.

Fund Raising & Donations:

 Several grants have been applied for including an M & M Area Community Foundation Grant and a Zion Lutheran Church Endowment Fund Grant.

Other/Personnel:

- Max Heckel has successfully completed his initial probation and has been promoted to active firefighter status.
- One applicant has been conditionally hired pending results of his pre-employment medical testing and physical exam.
- One new applicant is being scheduled for an interview.
- Our current roster stands at 21 volunteer firefighters. We are currently accepting applications.
