Thank you for the request. Our update is as follows. Please let me know if there are questions.

The site investigation (SI) field sampling was conducted in late September 2024 for the JCI Fire Technology Center site. Sampling consisted of collection of groundwater from private wells. It also included soil, sediment, and surface water collection from the JCI Fire Technology Center facility. EPA

mailed validated sampling analytical results from the private well samples to the residential owners regarding their wells in October and November 2024, once results were available. The draft SI report has been submitted by our contractor and is undergoing review and revision. At this time, we expect to have the report ready for release to the public later this winter.
